## SPECIFIC CRITERIA AND SCALE FOR THE SECOND PHASE OF THE EVALUATION


The candidates in the oral presentation/interview must complete, for a maximum of one and a half hours, a brief personal presentation (including their backgrounds and their teaching and research projects for the next five years in relation to the scope of the position offered and of the department where it is offered) followed by a seminar on a subject related to Food Sciences (Ciències de l'Alimentació), and the evaluation criteria for this oral selection test will be:

- 1) The quality of the research project and its presentation: 40 points
- 2) The quality of the teaching project and its presentation: 10 points
- 3) The quality of the seminar taught: 20 points
- 4) The quality of the answers to the questions raised by the committee members: 30 points

**Minimum score to surpass the second phase of the evaluation: 50 points**

## FINAL SCORE FOR THE SELECTION OF THE CANDIDATES

The final grade of the candidates will come from the average between the scores of the first and second phase.

Article 112 of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures allows you to appeal when resolutions and acts of procedural law directly or indirectly affect the basis of the legal process underway, obstruct that process, or undermine or cause irreparable harm to legitimate rights and interests. Under such circumstances, you may present a request for further review, in this case by the Rector, within one month from the day after the publication of the Committee's decision, pursuant to articles 121 and 122 of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures.*
