



RESOLUTION of 28 June 2021 of the University of Barcelona opening a call for applications for grants for the requalification of the Spanish university system for the period 2021–2023

In accordance with the provisions made in Royal Decree 289/2021, of 20 April, regulating the direct award of subsidies to public universities for the requalification of the Spanish university system, from funding allocated to European recovery, transformation and resilience funds, and with the applicable regulations.

Having regard to the provisions of Ministerial Order UNI/551/2021, of 26 May, which releases the subsidies provided for in Royal Decree 289/2021, of 20 April, to Spanish public universities, under which the University of Barcelona is allocated 20,160,033 euros (6,720,011 per year for each of the three annual periods) to be distributed over a minimum of 144 grants, which may be increased according to the specific characteristics and duration of the grants awarded.

In respect of the approval of multi-annual expenditure for the execution of the calls for applications deriving from the direct award of subsidies for the requalification of the Spanish university system, agreed on 27 May 2021 by the Economic Committee of the Board of Trustees, with the following annual distribution: 6,720,011 euros (2021), 6,720,011 euros (2022) and 6,720,011 euros (2023).

By virtue of the powers conferred on me by law, in particular by Article 73 of the University of Barcelona Statute, approved by Royal Decree 246/2003.

I HEREBY RESOLVE:

First. To open the call for applications for the grants allocated to the University of Barcelona under Order UNI/551/2021, of 26 May, which awards the subsidies provided for in Royal Decree 289/2021, of 20 April, distributed as follows across three types:

- Margarita Salas grants for the training of young doctoral graduates: a minimum of 120 grants, with a total value of 10,080,017 euros, distributed as provided for in the terms and conditions of the call for applications.
- Grants for the requalification of statutory and non-statutory university teaching staff: a minimum of 10 grants, with a total value of 1,230,016 euros, distributed as provided for in the terms and conditions of the call for applications.
- María Zambrano grants for the attraction of international talent: a minimum of 82 grants, with a total value of 8,850,000 euros, distributed as provided for in the terms and conditions of the call for applications.

Second. To request the publication of this resolution in the Official Bulletin of the Government of Catalonia, without prejudice to its publication on the same day in the University of Barcelona's E-Office.

Third. To approve the general terms and conditions applicable to this call for grant applications, the specific terms and conditions for teach type of grant and the respective appendices, which will be published in the University of Barcelona's E-Office on the same day as this resolution is published in the DOGC.

Fourth. To establish a period for the submission of grant requests of 20 working days from the date of publication of this resolution in the DOGC. The award of each grant must be finalized by 30 November 2021.

Contentious administrative proceedings may be opened against this administrative resolution, irrespective of the immediacy, or otherwise, of its execution, through the courts of Barcelona, starting on the day after the ruling and for a period of two months, in accordance with the provisions to this effect made in Article 8 of Law 29/1998, of 13 July, regulating contentious administrative jurisdiction. Interested parties may also lodge any other type of complaint or objection they deem appropriate.

An appeal of reversal may also be presented directly to the body in question, within one month from the day after the resolution is published. In this case, contentious administrative proceedings may not be opened until the appeal for reversal has been expressly or implicitly resolved, in accordance with the provisions of articles 123 et seq. of Law 39/2015, of 1 October, on common administrative procedure in public administrations.
