



Resolution of the Rector approving the definitive list of candidates admitted to and excluded from the selection process for the award of grants for the requalification of the Spanish university system for the period 2021-2023 and notifying the selection committees of the distribution of candidates admitted for each type of grant.

## WHEREAS

- 1. By resolution of the Rector of the University of Barcelona of 28 June 2021, the call for applications was announced for the award of grants for the requalification of the Spanish university system for the period 2021-2023 (Official Bulletin of the Government of Catalonia no. 8448, 2 July 2021).
- 2. On 28 September 2021, a resolution was published in the University of Barcelona E-Office announcing the provisional list of candidates admitted to and excluded from the selection process and the composition of the selection committees for each type of grant.
- 3. On 13 October 2021, the period for amendments to the provisional list closed.

## LEGAL GROUNDS

- 1. Without prejudice to content of the resolution published on 8 October 2021, the pertinent amendments having been reviewed, in compliance with Article 7.3 of the conditions of the call for applications the Rector is competent in the matter of approving and publishing the definitive list of candidates admitted to and excluded from the selection process.
- 2. Pursuant to Article 8.1 of the general terms and conditions of the grant call, it is also necessary to publish the distribution of candidates admitted to the selection process for each type of grant and to notify the corresponding selection committees.

By virtue of the powers conferred on me by law, in particular by Article 73 of the University of Barcelona Statute, approved by Royal Decree 246/2003.

## I HEREBY RESOLVE

**First**. To approve the definitive list of candidates admitted to and excluded from the selection process for the award of grants for the requalification of the Spanish university system for the period 2021-2023, together with the grounds for exclusion in each case, for each of the three types of grant offered, as attached to this resolution as Appendix 1.

**Second.** To notify the respective selection committees of the distribution of candidates admitted to the selection process for each type of grant, as detailed in Appendix 1.

Third. To publish this resolution and its appendices in the University of Barcelona E-Office (https://seu.ub.edu/).

Contentious administrative proceedings may be opened against this administrative resolution, irrespective of the immediacy, or otherwise, of its execution, through the courts of Barcelona, starting on the day after the ruling and for a period of two months, in accordance with the provisions to this effect made in articles 8 and 46 of Law 29/1998, of 13 July, regulating contentious administrative jurisdiction.

An appeal of reversal may also be presented directly to the body in question, within one month from the day after the resolution is published. In this case, contentious administrative proceedings may not be opened until the appeal for reversal has been expressly or implicitly resolved, in accordance with the provisions of articles 30, 123 et seq. of Law 39/2015, of 1 October, on common administrative procedure in public administrations.
