At 16h October 25th at, in an online session, the Arts and Humanities area selectioncommittee is duly constituted, , comprising and in the presence of all members indicated in this document, who are appointed in order to assess the proposed candidates in the selection process for the award of grants for the requalification of the Spanish university system for the period 2021-2023, in the category of María Zambrano grants for the attraction of international talent, announced by resolution of the Rector 28 June 2021, published in the Official Bulletin of the Government of Catalonia on 2 July 2021, with the following details:

Based on the evaluation criteria established in the general terms and conditions in accordance with article 9.2 of general terms and conditions of the call:

- a) Abbreviated curriculum of the candidate (up to 50 points)
- b) Scientific-technical trajectory of the host group or groups (30 points). Existing collaborations between the host group and the University of Barcelona will be evaluated.
- c) Justificatory report (up to 20 punts)

Candidates must obtain at least 80 points to pass the assessment,

Prior to receipt of the candidates' documentation, the Selection Committee AGREES on the following SPECIFIC CRITERIA (SC) to be applied to the applications received in accordance with the following scale:


SC 1 Abbreviated Curriculum of the candidate (50 points)

- Employment, fellowships, and grants obtained
- Scientific articles and research outcome, including artistic production: number, quality
- Participation in projects
- Participation in the writing process of books and chapters
- Participation in national and international congresses
- National and international mobility
- Training courses, diversity, and depth
- Participation in knowledge transfer activities
- Participation in science dissemination activities









Other merits (awards, etc...) and achievements

SC 2 Scientific-technical trajectory of the hosting group or groups (30 points)

UB HOST GROUP

The committee will evaluate the best outcome regarding: a) PDA (teaching dedication programme) punctuation in research of the mentor in his/her knowledge area. b) If applicable, punctuation of the SGR (consolidated research groups accredited by the government of Catalonia) in which the mentor is involved.

If the mentor has recently joined the UB and has no PDA for research, the productivity, and the impact of the research in the Knowledge area prior joining the UB will be evaluated

SC 3 Justificatory Report (20 points)

Report that justifies the adequacy of the candidate to the teaching, research, and knowledge transfer needs
of the host group and expected impact
