The signed confirmation must be sent by email to requalificacio.su@ub.edu or through electronic application at <https://www.ub.edu/eadministracio/IG.html> addressed to request *Recursos humans/PDI- Personal docent i investigador* (to the Academic Staff service), **within 15 working days of beginning the stay**.
 - Report on the activities carried out, confirming the start date and end date and justifying the content and impact of the period of training. The report must be signed by the grant recipient and by the principal investigator of the group at the host centre. Reports should be sent to the address vr.recerca@ub.edu at least three months before the end of each year in the grant period. Special authorization to send the report upon completion of the stay must be obtained from the Vice-Rector for Research.

For Margarita Salas grants carried out at two host centres, reports must be provided by each centre at the end of the respective stays.

6. Grant recipients acknowledge the University of Barcelona as the awarding body and will identify it as such in any publications, patents and other materials deriving directly from the work carried out during the grant period. They must also clearly identify the UB and the funding received in any
