#### **First Phase**

##### **1. Research merits (up to 55%)**

The significance and impact of research merits in the position profile (Animal Physiology) will be highly valued

###### 1.1 Significant academic achievements (up to 40%)

A high importance will be given to publications on indexed journals while other scientific publications, books and books chapters will be also considered. High quality papers and patents, and the position of the authors in the publication/patent will be taken into account.

###### 1.2 Periods in research and achievements at distinguished or reputed centers, different from the institution where the candidate performed his/her initial academic education (up to 5 %).

###### 1.3 Ability to get competitive funding, competitive grants or fellowships, coordination of projects, participation in research projects and/or research contracts and knowledge transfer/contract research (up to 10%).

##### **2. Teaching merits (up to 40%)**

Significance of teaching merits in the profile of the position (Animal Physiology) and the relevance/experience of the candidate to the academic priorities of the Section of Physiology will be highly appreciated.

###### 2.1 University teaching – quality and quantity of teaching experience, original teaching approaches and or material innovative teaching, particularly in the area of the position (up to 35%)

###### 2.2 Supervision or co-supervision of final degree bachelors projects or masters and doctoral thesis (up to 5%)

##### **3. Peer recognition (up to 5%)**

Other relevant research/teaching merits i.e., prizes, distinctions, invitation to conferences, chairing sessions, chairing competitions, reviewing, etc.

*Candidates receiving a score below 60 out of 100 cannot be selected for the second phase. Candidates will have to pass separately both research and teaching merits evaluation.*

### **Second Phase**

The selection committee will ask candidates to present orally the CV, including research and teaching activities (maximum 30 min), followed by a seminar (undergraduate student lecture) selected by the candidate on an animal physiology subject (maximum 40 min).

In assessing the candidates, the specific evaluation criteria described above will be used together with the quality of the candidate's presentation, the ability to answer the questions raised by the members of the committee and considering the suitability of the candidate for the position at the Section of Physiology of the Department.

### **Evaluation**

First phase score (40%)

Presentation of curriculum and defense (20%)

Presentation of a seminar related to the field of the position and defense (40%)

*A score of 60 out of 100 or higher will be required*

*This decision of the Committee is an act of procedural law and does not exhaust your right of appeal through administrative channels. Article 112 of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures allows you to appeal when resolutions and acts of procedural law directly or indirectly affect the basis of the legal process underway, obstruct that process, or undermine or cause irreparable harm to legitimate rights and interests. Under such circumstances, you may present a request for further review, in this case by the Rector, within one month from the day after the publication of the Committee's decision, pursuant to articles 121 and 122 of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures.*
