

Grants for the requalification of the Spanish university system 2021-23 Complementary call

Frequently Asked Questions (FAQS)

1. Is it enough to have read the thesis to apply for a grant?

No.


It is necessary to have processed the issuance of the doctoral degree and to have made the payment of the corresponding fees, on the date of the end of the term of presentation of applications, according to establish the bases of the announcement.

2. What is the FECYT CVA?

The CVA is the abbreviated curriculum model (CVN (fecyt.es)

3. How can I highlight, within the FECYT CVA, publications and other data that do not have their own chapter?

The FECYT guide on how to prepare the Abbreviated Curriculum Vitae (CVA) states that each user can highlight, in the "Free Curriculum Summary" section (attached image), other aspects that they consider relevant to their career and that do not has been listed in the sections that are displayed by default in the CVA.



4. Does the scientific project that I have to indicate in the application form, have to be a project already granted?

No.

The scientific project that you must indicate in the application form is the name - or title - of the scientific project that the researcher plans to develop during the stay.

This title will be stated in the employment contract that will be signed with each awardee of the requalification aid.

5. Does the mentor endorsing an application have to be the Principal Investigator (IP) of a research group or can he be a member of the group?


It should be the Principal Investigator, who coordinates the work of a research group, not a member of the research group.

6. How can I obtain the signature of acceptance of my application from the Vice-Rector for Research at the UB?









There are two ways:

- 1. The IP that endorses the application, submits it to the head of the Department for assessment and approval and, if applicable, subsequently submits it to the Vice-Rectorate for Research for final acceptance and signature, if applicable. In this case, this documentation will be returned to the applicant through the same internal channels that correspond to it so that it can provide it to the online procedure for applying for the grant.
- 2. The applicant already has the original document signed by the mentor or the mentor and the head of department. In this case, please send this document by e-mail to vr.recerca@ub.edu
- 7. By what day and time can I submit my online aid application?

Until 23:59 on July 6, according to the official time of the Spanish mainland.

8. If I am awarded a requalification grant, I will be staying in a country outside the European Union. Will I have to process the visa before signing the contract?

Yes.

You must present to the Academic Staff, before signing the employment contract, the visa issued by the competent entity of the country where you are going to stay.

9. What is an SGR?

It is the acronym that identifies the Consolidated Research Group.

10. If I am awarded a grant, will I be able to keep another part-time job?

According to the call, the successful bidder will sign a full-time contract with the UB for postdoctoral research staff.

This postdoctoral researcher contract may be compatible, upon request and authorization, provided that it complies with the general requirements of the incompatibility rules provided for in Law 53/1984 on incompatibilities and development rules (compatible working hours and hours, lack of conflict of interest ...).

In principle, once the above has been completed, it is expected that compatibility with an associate professor contract may be authorized (provided that this is not signed with the UB).

It may also be compatible, in general, with a private activity, provided that the provisions of article 12 of Law 53/1984, of incompatibilities, and in particular its first paragraph, are complied with.

11. Does the contract to be awarded to the winners of the Margarita Salas and María Zambrano grants contribute to Social Security?

Yes.

The contract that will be formalized for the winners of the grants Margarita Salas, Requalification (reader) and María Zambrano is an employment contract covered by the Law of Science, in the SECTI modality, and has all the legal benefits established by current regulations.
