#### 1. RESEARCHER MERITS

##### 50 points

- (a) Scientific work in mathematics education: scientific indexed publications (WoS and Scopus); scientific books and book chapters; other scientific publications **(20 points)**
- (b) Participation and leadership in research projects and/or research contracts. Activities in national and international research networks & periods in research centres **(15 points)**
- (c) Active participation in congresses, conferences, and seminars at prestigious international research centres **(10 points)**
- (d) Editing work and peer-reviewing of journals **(5 points)**

#### 2. TEACHING MERITS

##### 30 points

- (a) Teacher training for mathematics teaching and for university teaching. Participation in conferences aimed at university teaching **(5 points)**
- (b) Teaching experience in the field of **mathematics education** at the university level (bachelor's degree and/or postgraduate) **(5 points)**
- (c) Supervision of doctoral theses (completed and in progress). Supervision of tutored projects (master's degree final project, etc) **(5 points)**
- (d) Positive evaluations of teaching activity. Original teaching materials and teaching publications **(5 points)**
- (e) Teaching innovation projects. Activity in continuing education of teachers **(5 points)**
- (f) Disassociation from the hiring university (UB). Work in other institutions and schools **(5 points)**

#### 3. COMMUNITY SERVICE. KNOWLEDGE TRANSFER

##### 10 points

- (a) Community service in the field of **mathematics education** **(3 points)**
- (b) Responsibilities in **scientific and professional organisations** **(4 points)**
- (c) **Dissemination and transfer** activities or publications **(3 points)**

#### 4. OTHER ASPECTS

##### 10 points

- (a) Awards **(2 points)**
- (b) University management positions or work in committees **(3 points)**
- (c) Other merits, including competence in English language **(5 points)**

First phase: 70 points (100)

*To access the second phase candidates must have at least 70 points given by three members of the committee.*



**2nd phase:**

Personal presentation.

- a) accumulated merits,
- b) project planned involvement in research groups and teaching or learning if hired.

Seminar (subject freely chosen by the candidate)

A ranked list will be made adding:

- The points obtained in the first phase
- A maximum of 10 points for a personal presentation
- A maximum of 10 points for a project planned
- A maximum of 20 points for the presentation of the theme of the seminar

The candidate with more points will be proposed to be hired.

*Contra este acuerdo de la comisión, que no agota la vía administrativa y es un acto de trámite, es aplicable lo establecido por el artículo 112 de la Ley 39/2015, de 1 de octubre, de procedimiento administrativo común de las Administraciones Públicas, según el cual contra las resoluciones y los actos de trámite, si estos últimos deciden directamente o indirectamente el fondo del asunto, determinan la imposibilidad de continuar el procedimiento, producen indefensión o perjuicio irreparable a derechos e intereses legítimos, los interesados pueden interponer recurso de alzada, en este caso ante el rector, en el plazo de un mes, a contar a partir del día siguiente de su publicación, de acuerdo lo que establecen los artículos 121 y 122 de la Ley 39/2015, de 1 de octubre, del procedimiento administrativo común de las administraciones públicas.*

*This decision of the Committee is an act of procedural law and does not exhaust your right of appeal through administrative channels. Article 112 of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures allows you to appeal when resolutions and acts of procedural law directly or indirectly affect the basis of the legal process underway, obstruct that process, or undermine or cause irreparable harm to legitimate rights and interests. Under such circumstances, you may present a request for further review, in this case by the Rector, within one month from the day after the publication of the Committee's decision, pursuant to *articles 121 and 122* of Law 39 of 1 October 2015 on the legal framework governing public administrations and common administrative procedures.*
