BIAP_POSTDOC_WP6 In 2022, the Spanish Ministry of Science and Innovation (MCIN) recognized the Barcelona Institute of Analytic Philosophy (BIAP) as a María de Maeztu Unit of Excellence, a status involving a 2M Euro grant for a 4-year collaborative research project on the nature and role of evidence. The project's main objectives are to (1) explore and systematize the different roles, and scope, assigned to evidence in a variety of well-defined contexts of enquiry, (2) develop a coherent overall conception of the nature of evidence, and of evidential support, across the aforementioned contexts of enquiry, (3) determine the lessons to be drawn from this conception for the uses and roles that evidence should have in the public sphere. The project is articulated into 6 research work packages, of which one, WP6, is in legal and political philosophy (for further information, go to <a href="https://www.ub.edu/biap/">https://www.ub.edu/biap/</a> ). As part of its strategic research programme, BIAP seeks to attract national and international talent working on issues within the project's remit. The successful candidate is expected to work on issues related to evidence in legal and political philosophy, and to contribute to the pursuit of one of the following research objectives:  - to assess what kind of evidence determines the truth of our propositions of law;  - to assess the role and relevance of evidence in democratic deliberation and decision-making;  - to assess the role of evidence-based public decision-making for the effective protection of members of vulnerable groups and their human rights;  - to assess whether and why different standards of evidence may be required or acceptable in different domains of in which authority by some over others may be exercised.  The successful candidate is further expected to actively participate in BIAP's research activities and in the organization of research and outreach events.

Selection process	Applications, including all the requested application material (except the reference letters), must be submitted before the deadline via the General Registry of the University of Barcelona: <a href="https://www.ub.edu/eadministracio/en/IG.html">https://www.ub.edu/eadministracio/en/IG.html</a> , with the call identifier BIAP_POSTDOC_WP6 mentioned under 'details of request'. The selection committee will review all applications for this position, check for eligibility, and draw up a longlist from among those candidates reaching an evaluation score of at least 50%. Longlisted candidates will then be invited for interview. Online interviews are expected to be held within 10 working days from the deadline. After the interviews, and no later than end of February, the panel will draw up a shortlist, ranking the shortlisted candidates according to standard scientific criteria and the extent to which the candidates' academic profiles fit the institute's research agenda. The successful applicant will be notified shortly after the shortlist has been agreed. The successful candidate then has a maximum of 10 working days to reach a decision. If the candidate ranked 1st declines the offer, the candidate ranked 2nd will receive an offer, and so on until the end of the shortlist is reached. If no shortlisted candidate accepts the offer, a new call will be issued. (The same applies if no applicant reaches an evaluation score of at least 50%.) In case of acceptance, the successful candidate then has max. 3 months (if an EU-citizen) or 6 months (if a non-EU citizen) to provide all necessary documentation and sign the contract. (For non-EU citizens, the date of incorporation may thus deviate from the orientative starting date mentioned above.) For non-Spanish citizens, the necessary documentation will include an official recognition of equivalency of their PhD by the U. of Barcelona's 'Escuela del Doctorado', a Spanish social security number (NASS), and evidence of the holding of a Spanish bank account. For non-EU citizens, it will also include a work and residence permit (visa) for Spain, to obtain which will require additional documentation to be presented at a Spanish consulate/embassy (e.g. a police clearance certificate). The U. of Barcelona will issue a document certifying the offer of employment that will have to be submitted alongside these documents to obtain a work visa. Non-Spanish EU citizens must obtain a NIE (an identification number for foreigners) within 90 days after signing the contract; non-EU citizens must obtain a TIE card (an identification card for foreigners) upon their arrival.

#### Additional comments\*

**Duration of the contract of employment:** 2 years

The candidate proposed for hiring must accept the job offer within 10 working days from the date of notification of the selection.

Priority will be given to people with disabilities (Law 89/2015 of June 2, reserve of quota 2% in favour of people with disabilities in companies of 50 or more people).

Once these terms and conditions have been completed, they must be sent to the General Affairs Office, along with the document confirming the budget availability. The reference unit will prepare the resolution of the call for applications and post it on Euraxess.
