The publication record stores electronic evidence of the publication and availability of content in the E-Office.

Electronic evidence is the trail left by content published in the E-Office. It indicates the moment at which content was published, the time it remained available and who was responsible for publishing or unpublishing each element.

Electronic evidence maintains the chain of custody, preserving the integrity of records such that they are suitable for presentation in court. This safeguards the rights of individuals and ensures the independence and transparency of the content published in the E-Office.
